



## **Catshill and North Marlbrook Parish Neighbourhood Plan**

### **Final Decision Statement published pursuant to Section 38A Planning and Compulsory Purchase Act 2004 (as amended) and Regulation 19 of the Neighbourhood Planning (General) Regulations 2012 (as amended)**

#### **1. Summary**

Following a referendum on the 7th October 2021, in which more than half of those who voted did so in favour of the neighbourhood plan, a decision has been taken to make the Catshill and North Marlbrook Parish Neighbourhood Plan (2016-2030) part of the statutory development plan for the district. This decision was taken at a meeting of Bromsgrove District Council on 3<sup>rd</sup> November 2021. This statement sets out the reasons for the Council making this decision.

#### **2. Background**

The Catshill and North Marlbrook Parish Neighbourhood Plan area was designated by Bromsgrove District Council on 20<sup>th</sup> October 2016. The Parish Council submitted its neighbourhood plan to the Council on 8<sup>th</sup> January 2021. This plan had been subject to a six-week statutory representation period between 21<sup>st</sup> September and 2<sup>nd</sup> November 2020.

The Council appointed an independent examiner to assess whether the neighbourhood plan was deemed to meet the basic conditions and whether it could proceed to referendum. The examiner's report was received on 3<sup>rd</sup> June 2021. This concluded that, subject to a series of minor modifications, the plan met the basic conditions and other legal requirements, and could proceed to referendum.

On the 24<sup>th</sup> June 2021, the Council published a Decision Statement under regulation 18 of the 2012 Neighbourhood Planning (General) Regulations (as amended) confirming that all of the modifications recommended by the examiner had been accepted and that the plan, as modified, met the basic conditions and should proceed to a public referendum.

A referendum relating to the Catshill and North Marlbrook Parish Neighbourhood Plan 2016-2030 was held on Thursday 7<sup>th</sup> October 2021. The referendum question asked was: "Do you want Bromsgrove District Council to use the Neighbourhood Plan for Catshill and North Marlbrook Parish to help it decide planning applications in the neighbourhood area?"

Paragraph 38A(4)(a) of the 2004 Planning and Compulsory Purchase Act (as amended) requires that the Council must make a neighbourhood plan if more than half of those voting have voted in favour of the plan. The results of the referendum were as follows:

- Total ballot papers issued: 822
- Ballot papers rejected: 1
- Ballot papers counted: 821
- Yes votes: 723
- No votes: 98
- Electorate: 5,198
- Turnout: 15.81%

### **3. Reasons for the Decision**

The Catshill and North Marlbrook Parish Neighbourhood Plan complies with the legal requirements and basic conditions previously referred to in this statement. It has also been subject to a referendum, and more than half of those who voted were in favour of the plan. As such it can now be formally 'made' by the District Council and become part of the statutory development plan for deciding planning applications in the designated neighbourhood area.
