

- 01 - New public realm/seating area linking St. John Street & Worcester Road
- 02 - New public realm and seating area to the rear of the Dog & Pheasant pub creating a space that is enjoyable to stop, rest and enjoy the renaturalisation of the Brook
- 03 - Online pond to enhance and encourage potential water vole habitat and help stabilise water levels
- 04 - Offline ponds that enhance and encourage potential water vole habitat as well as providing sustainable urban drainage opportunities for the proposed development sites. These ponds will also help with stabilisation of water levels
- 05 - New pedestrian access from Sanders Park onto a new footpath and cycle path running parallel to the proposed realignment
- 06 - Improved pedestrian crossing to John Street
- 07 - New public realm and seating area. Linking the two proposed sections of Spadesbourne Brook with an informal seating area on a site that is currently used as a car park
- 08 - Proposed alignment for the section to be culverted
- 09 - Improvements to the legibility and integration of Little Lane to the proposals.
- 10 - Proposed footbridge over the Brook improving the pedestrian flow from St. John Street to Worcester Road and also linking the wider context of St. John the Baptists Church
- 11 - Brook opened up in the unused space between the two lanes on St. John Street adding visual improvements to the street scene
