Whilst The Coal Authority generally considers the Bromsgrove District Plan to be sound, we do consider that the plan is lacking an effective 'signpost' to those other parts of the Development Plan for the district which are prepared by Worcestershire County Council. The submission BDP fails to make reference to the adopted Worcestershire Waste Local Plan or the emerging Worcestershire Minerals Local Plan and acknowledge that policies/proposals from those plans may need to be illustrated on the Policies Map that accompanies the BDP. The Coal Authority considers that it would be highly beneficial for plan users to fully understand the linkages between the BDP and all other planning documents that impact on the district.
