Thank you for your letter.

The GTAA which has been produced by ARC4 LTD is a comprehensive study and on behalf of the NFGLG, I offer qualified support for its findings. The one area of concern is the adoption of negative levels of need as a basis for moving towards ongoing requirements. The fact that Bromsgrove may currently have a theoretical over-provision should not, in our view lead to that "over-provision" being offset against future needs.

There is a inevitably going to be additional demand over the next 5 years in Bromsgrove for pitches and the fact that the figures can be interpreted as showing an excess of sites will be of no practical assistance to the Travellers who are the source of that need. In my view, any excess of supply over assessed need should be discounted in projecting ongoing need. At the very least, this demonstrates that any provision for sites in the Local Plan must be regarded as a minimum.

These are the only additional comments the NFGLG would wish to make apart from the original comments we made in November 2013. Please advise the Inspector accordingly and convey our thanks for this opportunity to make further representations.
